This MoU is non-committal and the relationship of the Parties under this MoU is non-exclusive. Any Party may collaborate with any third party for the services/collaboration contemplated under this MoU without informing to each other.

37. TERMS AND TERMINATION

This MOU shall be valid for a period of 1 year from the Effective Date unless extended by mutual written agreement of the Parties. Either Party shall have the right to terminate this MoU by serving 60 days prior written notice to the other Party.

38. RELATIONSHIP

This MoU is non-binding and nothing in this MoU shall be construed to make either Party a partner, an agent or legal representative of the other Party for any purpose.

39. ASSIGNMENT

It is understood by the Parties that this MoU is based on the professional competence and expertise of each Party and hence neither Party shall transfer or assign this MoU or rights or obligations arising hereunder, either wholly or in part, to any third party.

40. GOVERNING LAW

This MoU shall be governed by laws applicable in India and shall be subject to exclusive

jurisdiction of courts at Jaipur, India.
